1.0. About Zizi Afrique Foundation

2.0 Background information

One of Zizi Afrique's ways of working is partnership with the Government, to achieve system-led change at scale. The Zizi Afrique – Government initiative dubbed Napenda Kusoma was inspired by the municipality of Sobral in Brazil, with the vision of ensuring that all children in Kirinyaga can read with comprehension by the end of Grade 3 in 2026. The government spearheaded the Foundational Literacy Program, with the Teacher Service Commission County Director (TSCCD) as the chief convener and patron and supported by the County Director of Education and the County Executive Committee Member (CECM) for Education in the Kirinyaga County government as co-convenors. The program targets to shift the classroom practices of the Early Years Education (EYE) teachers, including the Early Childhood Development Education (ECDE) teachers employed and managed by the county government and the Grade 1-3 teachers, with a view to improving literacy outcomes.

In the past year, Napenda Kusoma project team accomplished, among other things, capacity building sessions for teachers on developing formative assessment tools and learning materials. The team also conducted trainings to orient teachers on targeted instruction as a strategy for hastening acquisition of literacy competencies for learners lagging behind, which has resulted in teachers shifting their classroom practices to facilitate literacy achievement.

Purpose of Consultancy

Zizi seeks to engage the services of a qualitative research consultant to document the process outcomes, lessons and insights emerging from the partnership.

2.0 Objective

- This consultancy seeks to: Document the key aspects of the project implementation, including strategies, processes, challenges faced, lessons learned, and recommendations for improvement.
- 2. document the shifts in classroom processes, methodologies, and practices inspired by the Napenda Kusoma initiative in Kirinyaga County.
- 3. Package a comprehensive report detailing what has changed, why and how, as well as recommendations on the way forward.
